As requested, Hawkeye Services, LLC (Hawkeye) sent a technician to 25 Maple Avenue in West Orange, NJ on August 2, 2018. The purpose of this service is to locate and identify if any undisclosed or abandoned Underground Fuel Oil Storage Tanks (USTs) exist on the property.

The technician entered the building to check for evidence of previous oil service, such as fuel distribution lines, adjacent to the existing heating system. In addition to the active 275-Gallon Basement Fuel Oil Storage Tank (BST) the technician discovered a pair of cut and crimped fuel lines exiting the front foundation wall and entering floor indicating a previously removed UST.

The technician returned outside and visually checked the grounds for any vent pipes or oil fill pipes which may indicate an oil tank. During the technician's visual inspection, no vent or fill pipes were discovered.

The technician then used a Schonstedt GA-52Cx inductive and conductive locator to search the entire property. The Schonstedt GA-52Cx inductive and conductive locator is capable of locating metallic objects up to a depth of eight (8) feet. The technician's testing did not reveal the presence of any buried USTs. The areas under the front masonry steps, right side concrete walkway containing rebar or wire mesh and rear shed were inaccessible and therefore excluded from the sweep.

In summary, no Underground Fuel Oil Storage Tanks were located at the subject property. Hawkeye Services guarantees our work. Should a UST be discovered on this property in the future, while our client is the owner, Hawkeye will remove the UST at no charge.
